Epidemiology includes, among its basic concepts, terms such as: epidemic, endemic and pandemic. The first two are often discussed in classes and epidemiological studies. Stefan Chunha Ujvari, in his book on pandemics, he brought a historical analysis of infections that affected the world and discussed how they modified and shaped the lives of people who experienced this situation. The author highlighted the ease of adaptation of microorganisms, increasing their chances of survival among humans, observing the speed of population displacements that must be considered with regard to control and surveillance measures against the disease.

A pandemic means the appearance of an epidemic in several countries around the world. There were many pandemics faced by the human being, some diseases such as bubonic plague, smallpox, cholera and Spanish flu. At the moment, we are experiencing the challenge of facing SARS-CoV-2, caused by a new Coronavirus, which is impacting everyone's lives, impacting the economy and mental health.

The characteristics of the virus transmission, the high number of infected people, whether with symptoms or asymptomatic, and the lack of a vaccine, associated with the absence of specific drug therapy, reveal a worrying picture of the situation with the low coverage and availability of tests for the virus. Thus, it was demonstrated that no country in the world was prepared to face the situation, even among those more developed. Brazil has been adopting preventive measures, including social isolation, personal and environmental hygiene and the correct use of masks.

It appears that the confrontation of this pandemic has, in Public Health and epidemiological information, essential roles aimed at the entire population, highlighting the groups with the highest risk of contamination, such as health professionals at the front line of work in health.

Despite the emergency situation currently experienced, other aspects of human health continue to happen and need attention and study. In this way, aspects about "Maternal Experiences in Intra-family Sexual Abuse of Girls Institutionally Sheltered" and "Voice Symptoms and Other Complaints Associated with the Work of Teachers in Public Schools" are discussed.

The reader will also find themes related to Oncology Nursing, perception of this professional category about the Health Education Practice. And, involving the life of the undergraduate student in health, there are articles on Clown Therapy in medical training and the Curricular Structure of Physiotherapy Courses.

Thus, it is expected to contribute to Collective Health with the hope of better days for humanity.
